That the Company hereby, places the "Terms and Conditions and Rules for the Services", as prescribed by the Bank on its site i.e. www.yesbank.in for the Net Banking / Mobile Banking / Debit Card facility/ Cash Management/On line Trade Services as currently applicable, on record and confirms its acceptance of the same and that any of the persons mentioned hereinabove be and is hereby authorized to singly/jointly, sign or execute the application for availing the Services on the Terms and Conditions and Rules for availing such Services.

8. That the above mentioned Authorised person is authorized to sub delegate all the authorities mentioned above to any of the official of the Company, for exercising all or any of the authorities conferred under this resolution, from time to time.
