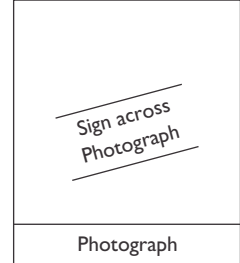

1. All particulars / information given in the application form are true and complete and no material information has been suppressed / withheld. I / We acknowledge that YES BANK Limited ("the Bank") shall have no liability for any consequences arising out of any erroneous details provided by me / us. I / We authorize the Bank to carry out such credit checks and at such time as it may deem necessary. The Bank may sanction this Loan at its sole discretion.
2. 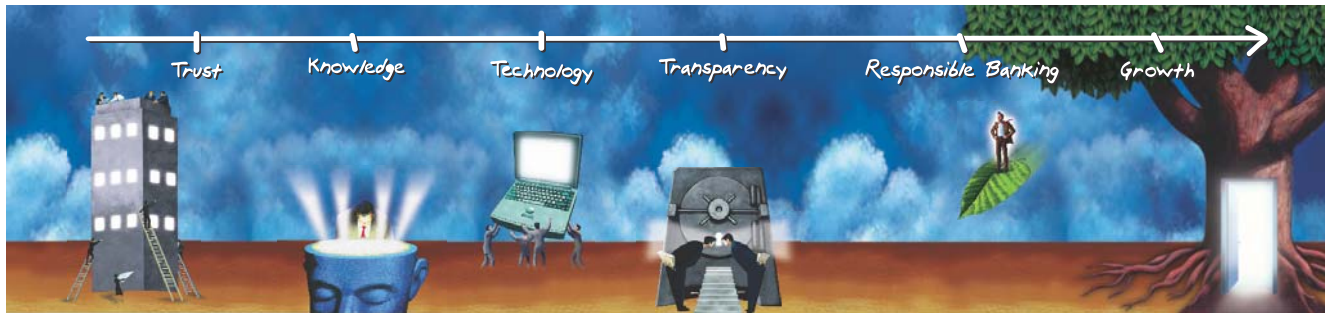
