Offer Terms and Conditions

What is the offer?

- Under the Offer the eligible YES BANK Credit Cardmembers/s can earn Amazon e-Voucher on their net retail spends* done during the Offer Period.
 - ***Retail spends** will include all spends done at Point of Sale, Online (Either Domestic or International) and will **not** include cash withdrawals done on YES BANK Credit Card
- During the Offer Period, Cardmembers will need to achieve equal to or greater than the net spend requirement as communicated to each such YES BANK Credit Cardmember
- On meeting the net spends requirement, Cardmembers will be eligible for an Amazon e-Voucher of specific denomination as communicated to each such YES BANK Credit Cardmember
