

Terms and Conditions – NetBanking Registration Reward Microsite

I. Definitions

- "Alliance Partner" shall mean CouponDunia, who has entered into an alliance agreement with YES BANK for the purpose of providing various offers to the customers of YES Bank who will register with the YES BANK Retail Internet Banking services.
