INDICATIVE GUIDELINES / CHECKLIST FOR THE APPLICANT FOR ENSURING ERROR FREE SUBMISSION

1] Please ensure the following in the bank guarantee format submitted by you :

- a) It has Yes Bank's regd. Office address i.e. _____
- b) It has the bank's standard notwithstanding clause at the end of the bank guarantee text.

Quote

Notwithstanding anything contained herein above in the Guarantee;

- i) Our liability under this bank guarantee shall not exceed Rs./-(in words Rs..... Only)
- ii) This bank guarantee shall be valid upto
- iii) We are liable to pay the guarantee amount or any part thereof under this bank guarantee only and only if you serve upon us a written claim or demand at Yes Bank Ltd ,-----office on or beore-----**Unquote**

c) BG should not generally include clauses like:

"Invocation acceptable on telex or fax or on letter when posted by beneficiary"
"Guarantee will be valid till it is discharged by the beneficiary"
"We will renew the guarantee on our own till beneficiary discharge's us from liabilities"

- d) BG should not contain any Onerous clauses
- e) BG should not be on auto renewal basis
- f) BG generally should not have expiry period of more than 10 years.
