

## Cashback worth Rs.250 on Spends 10<sup>th</sup> Dec 2019 to 31<sup>st</sup> Dec 2019

### Offer Terms and Conditions

#### What is the offer?

- Under the Offer the eligible YES BANK Credit Cardmembers can earn Cashback worth **Rs.250 on their retail transactions\*** done during the Offer Period
